INSTRUCTIONS TO VOTER

1. Use a **BLACK** pen.
2. **TO VOTE YOU MUST BLACKEN THE OVAL (●) TO THE LEFT OF YOUR CHOICE COMPLETELY.** An oval (●) blackened to the left of the name of any candidate indicates a vote for that candidate.
3. To cast a **write-in vote** for a person whose name is not on the ballot, **blacken the oval (●) to the left of the line** provided for that purpose.
4. If you make a mistake **DO NOT ERASE.** Ask for a new ballot.
5. **REMOVE STUB** before casting ballot.

STRAIGHT PARTY

You may vote a **Straight Party Ballot** for the party of your choice by darkening the oval to the left of the party of your choice
OR
You may **split your ballot** by darkening the oval to the left of the party of your choice and voting for individual candidates in any other party.

CRIME VICTIM RIGHTS
