

**JOINT MOTION FOR ENTRY OF A SECOND REVISED SCHEDULING
ORDER**

Pursuant to the Court's correspondence of November 23, 2016 regarding a possible discovery cutoff of January 31, 2017, all parties respectfully submit this Joint Motion for Entry of A Second Revised Scheduling Order. This Second Revised Scheduling Order sets forth agreed-upon dates and would amend the dates set forth in the Revised Scheduling Order, which was entered on March 11, 2016. Specifically, as suggested by the Court, this Second Revised Scheduling Order sets January 31, 2017 as the close of fact discovery. The remaining dates are set at intervals consistent with the previous scheduling orders in this case.¹

¹ The intervals may not be exactly the same as those in the previous scheduling orders entered on March 11, 2016, to ensure that deadlines do not fall on a weekend. In addition, the previous scheduling orders provided dates for personal jurisdiction briefing. These dates are not replicated in the attached proposed order as the Court has already heard and ruled on this issue.




