JOINT STIPULATION REGARDING
DEFENDANTS' RESPONSE TO PLAINTIFFS' COMPLAINT

Whereas, on January 7, 2014, this Court entered an Opinion and Order sustaining, in part, and overruling, in part, Defendant National Collegiate Athletic Association ("NCAA"), Mark Emmert, and Edward Ray's (collectively, "Defendants") Preliminary Objections to Plaintiffs May 30, 2013 Complaint (the "Original Complaint");

Whereas, the Court granted Plaintiffs leave to file an Amended Complaint within thirty days of the date of the Opinion and Order, which is February 5, 2014, and Plaintiffs presently intend to file such an Amended Complaint;

And whereas, if the NCAA were required to answer the Original Complaint, Pennsylvania Rule of Civil Procedure 1028(d) would provide the NCAA with twenty days from the date of the Opinion and Order, which is January 27, 2014¹, and that will occur before Plaintiffs' deadline to file an Amended Complaint;

Therefore, the parties, by and through undersigned counsel, agree and jointly stipulate as follows:

1. If Plaintiffs do not file an Amended Complaint, the NCAA's answer to the Original Complaint shall be timely if served on or before February 25, 2014;
2. If Plaintiffs file an Amended Complaint, the NCAA will have no obligation to answer the Original Complaint, and Defendants shall file preliminary objections—or otherwise respond—to the Amended Complaint by March 7, 2014.


¹ Defendants Emmert and Ray raised preliminary objections based on a lack of personnel jurisdiction. Those preliminary objections have not been resolved, and Defendants Emmert and Ray continue to preserve and assert them. The parties have agreed that any decision on Defendants Emmert's and Ray's preliminary objections based on a lack of personal jurisdiction will be deferred until discovery adequate to resolve them has been completed. Until that occurs and a decision is made by the Court, Defendants Emmert and Ray will not be obligated to file an answer.




