- 2. You shall not be in the lone company of, or in a supervisory capacity of, any minor child.
- 3. In the event the Defendant posts bail, he will be placed on the Electronic Monitoring/In Home Detention Bail Program under the direct supervision of the Centre County Probation/Parole Department. The defendant shall pay a fee of \$12 per day while on the Electronic Monitoring/In Home Detention Program.

- 5. There will be no firearms(this includes refles, shotguns, BB guns, air rifles, black powder firearms, paintball guns and any type of handgun) ammunition, alcoholic beverage or non-prescribed medications permitted at the Defendant's residence, 130 Grandview Road, State College, PA 16801.
