


Counsel hereby certify that we have petitioned the Grand Jury Supervising Judge, the Honorable Norman Krumenacker, III, to unseal information as ordered by this Court. Since the Grand Jury Supervising Judge previously denied a motion to unseal and a request for the appointment of a special prosecutor, the undersigned filed a Petition for Review with the Supreme Court thereby potentially removing jurisdiction from the Grand Jury Supervising Judge.¹ Accordingly, counsel has also renewed its request, as part of that appeal, that the Pennsylvania Supreme Court direct that the information be unsealed.

¹ The motion and an Addendum to Mr. Sandusky's Petition for Review were filed under seal based on the prior sealing orders of Judge Krumenaker and therefore are not attached.


