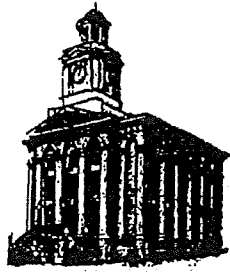


Dear President Judge Foradora,
