### **MEGAN'S LAW NOTICE**

#### TO THE DEFENDANT:

You have been convicted of the following crime(s):

Involuntary Deviate Sexual Intercourse – 8 counts Indecent Assault – 7 counts Unlawful Contact with Minors – 9 counts PILED FOR RECORD

You have also been determined to be a sexually violent predator:

These offenses come under a law known as "Megan's Law.: (42 Pa.C.S.A. 9791 et seq.)

That law places several obligations on you. Generally speaking, you are obligated to register any residence address with the Pennsylvania State Police, register any changes of residence addresses with the Pennsylvania State Police, register with the State Police of any other state you move to, and verify your residence address.

# Pursuant to Title 42, Section 9795.3, you are specifically informed of the following duties:

- 1. You are required to register with the Pennsylvania State Police and provide the information required for each registration including verification as required by Section 9796(a) relating to verification of residence. You must do that upon release from incarceration, upon parole from a state or county correctional institution or upon the commencement of a sentence of intermediate punishment or probation. You must verify your residence every ninety (90) days.
- 2. You have a duty to obtain the information required for each registration. You may obtain that information from any office of the Pennsylvania State Police.

- 3. You have a duty to inform the Pennsylvania State Police within forty-eight (48) hours of any of the following:
  - a. if you change residence or establish an additional residence or residences; or
  - b. if you change employer or employment location for a period of time that will exceed 14 days, or for an aggregate period of time that will exceed 30 days during any calendar year; or
  - c. if you terminate employment or change the institution or location at which you are enrolled as a student, or terminate enrollment.
- 4. If you fail to establish a residence as defined in Section 9792, (a "residence" is defined as a location where you reside, or are domiciled, or where you intend to be domiciled for 30 consecutive days or more during a calendar year,) then you must inform the Pennsylvania State Police of the following:
  - a. the location of a temporary habitat or other temporary place of abode or dwelling, including a homeless shelter or park, where you are lodged;
  - b. the places where you eat, frequent, and engage in leisure activities and any planned destinations, including those outside this Commonwealth; and
  - c. the place where you receive mail, including a post office box.
- 5. You are required to register with a new law enforcement agency if you move to another state within forty-eight (48) hours after establishing residence in another state.
- 6. You also have the duty to register with the appropriate authorities in any state in which you are employed, carry on a vocation or are a student, if that state requires such registration.
- 7. You are ordered and directed to cooperate with the Pennsylvania State Police in giving your fingerprints and photographs, and your fingerprints and photograph shall be given to the Pennsylvania State Police within thirty (30) days after you are sentenced.
- 8. If you do not comply with these registration requirements within the required time periods, it constitutes a second-degree felony carrying a three year mandatory minimum sentence. A subsequent non-compliance constitutes a first-degree felony carrying a mandatory minimum five-year sentence. Furthermore, if you provide false information when you register you are subject to a mandatory minimum five-year sentence. If you provide false information a subsequent time you are subject to a mandatory minimum seven-year sentence.
