AND NOW COMES, Petitioner, Gerald A. Sandusky, by and through his counsel, Alexander H. Lindsay, Jr., Esq., and J. Andrew Salemme, Esq., and the Lindsay Law Firm, P.C., and files this Motion to Clarify the Witnesses Who Will be Permitted to be Called and avers the following:

The parties on May 10, 2016 participated in a telephone status conference. Based on that conference, the PCRA Court made clear that Petitioner would be permitted to present the testimony of Attorney Frank Fina, Attorney Joseph McGettigan, and Judge Barry Feudale.
