ORDER

AND NOW, May 21, 2012, upon consideration of the Defendant's Supplemental Pre-Trial Motions/Motion in Limine,¹ it is ordered as follows:

1. "Motion in Limine No. 1 – Motion to Dismiss/Due Process/Non-Specificity of Allegations Contained in Criminal Information."
 - a. The Commonwealth shall submit its reply brief on or before the close of business on Friday, May 25, 2012.
2. "Motion in Limine No. 2 – Petition for Writ of Habeas Corpus."
 - a. The Commonwealth shall submit its reply brief on or before the close of business on Friday, May 25, 2012.
3. "Motion To Compel Commonwealth to Provide Defendant With Written Statement Of Uncharged Misconduct Evidence."
 - a. The motion is granted, and the Commonwealth shall supply to counsel for the defense the information requested in the motion on or before May 30, 2012.
4. "Motion to Compel Limited Compliance With Defendant's Subpoenas Duces Tecum."

¹ This motion was filed before the Commonwealth filed its Amended Information and Amended Bill of Particulars and addresses alleged defects in the Information and Bill of Particulars as originally filed. However, the Court will apply the legal theories asserted by the Defendant in its analysis of the Amended Information and Amended Bill of Particulars.



5. "Motion For Early Release Of Grand Jury Materials."
 - a. The Supervising Judge of the Grand Jury has been made aware of the Defendant's motion; and, as previously ruled, this Court will not presume to exercise any authority over any materials under the control of the investigating grand jury or the Supervising Judge.
6. "Motion For Supplemental Juror Questionnaire."
 - a. This motion is taken under advisement and will be considered in light of suggestions also made by the Commonwealth and all applicable state and federal law.
7. "Defendant's Third Motion To Compel Pre-Trial Discovery."
 - a. This motion is taken under advisement and will be addressed at a supplemental pretrial conference at which specific responses which defense counsel contends are incomplete will be addressed.
