ORDER

AND NOW, AUGUST 4, 2014, it appearing as follows: that Alexander H. Lindsay, Jr. has entered his appearance on behalf of the Defendant; that prior counsel, Joseph L. Amendola, has requested permission to turn over materials in his defense file, including Grand Jury transcripts and other Grand Jury materials provided to the defense pursuant to pretrial discovery, to Mr. Lindsay; that by letter dated July 30, 2014 Chief Deputy Attorney General James P. Barker has evidenced the Commonwealth's consent with the understanding that Mr. Lindsay and his agents and associates are bound by the Protective Order of June 26, 2012.


And further, that the Court has consulted with the Hon. Norman A. Krumenacker, III, Supervising Judge of the Grand Jury, who has expressed no objection to Grand Jury transcripts and materials in Mr. Amendola's files being turned over to Mr. Lindsay, provided Mr. Lindsay and any agent or associate who will be reviewing the Grand Jury transcripts and materials signs a secrecy oath in the attached form and delivers the signed oath to him;

Therefore, it is ordered as follows:

1. That before receiving any otherwise secret Grand Jury transcripts or materials, Mr. Lindsay shall sign a secrecy oath and deliver the same to the Supervising Judge of the Grand Jury. Any agent or associate of Mr. Lindsay who will have access to the said transcripts and materials shall also first sign the secrecy oath before gaining access to the said transcripts and materials.
2. That a copy of the secrecy oath signed by Mr. Lindsay and any agents or associates shall also be filed of record in these proceedings in the Court of Common Pleas of Centre County.

3. That when the secrecy oaths have been delivered to Judge Krumenacker and filed of record in Centre County, Mr. Amendola may deliver the said Grand Jury transcripts and materials to Mr. Lindsay without further Order.
