AND NOW comes counsel of record and answers as follows:


1. The Commonwealth has sought compliance with a previous Order of this Court, which is unusual as they are supposedly not the beneficiary of the Order and would not appear to have standing.
2. Counsel will not answer seriatim, nor does Counsel entirely agree with the case history as spun by the Commonwealth, but taking umbrage is neither now necessary nor pertinent.
3. Counsel has simultaneous with this answer filed a statement as required under seal, and in secret from the Commonwealth.
4. In turning back Counsel's appeal the Superior Court indicated these filings would not be shared with anyone but the Court, and Counsel so complies in specific reliance on the Superior Court's Order and Opinion in this matter, which is the law of the case.
5. Nonetheless the Court has left open the possibility of the materials being shared.
6. Counsel has obtained from your Honor a protocol for the filing and will comply with the protocol.

7. The Acting Supervising Grand Jury Judge specially assigned to Sandusky matters was separately contacted yesterday after his contact information was provided by the Attorney General, and no response has been heard as to what protocol for filing that judge will accept.
8. Counsel intends to provide an additional copy of the statement to said Judge so long as it will be handled in a similar matter and not provided to any third party.
9. No copy of the statement is being provided to the Commonwealth in any capacity.
10. The petition herein answered is now moot.

WHEREFORE Counsel requests the hearing be canceled.
